

## Payment of Membership Subscriptions

### 1. The Subscription Year

The subscription year corresponds with the calendar year 2010. Subscriptions for the 2009 membership are due on 1st January 2009.

Membership will lapse unpaid if the total subscription due has not been received in full by 31st January 2010 unless a monthly instalment scheme has been agreed with the Darlington Golf Club (Members) Ltd.

Resignation or requests to change membership categories must be made in writing to the Management Committee.

Any requests for refund, cancellation or reduction in payment will be assessed and decisions made at the Managements discretion.

### 2. Methods of Payment

A subscription may be paid by

- Cash
- Cheque made out to the Darlington Golf Club (Members) Ltd
- Credit or Debit card
- 10 monthly payments by Standing Order on an account at a UK Bank or Building Society. There is an additional charge applied to this method of payment.

The facility to pay by monthly instalment is available subject to the terms and conditions set out below.

#### Monthly Instalments

Any member taking up the Standing Order facility confirms acceptance of the terms thereof and the binding obligation to pay the full amount over the period of the agreement.

#### Eligibility

The option to pay in monthly instalments is available to members who -

- have no arrears outstanding on 1st January 2010
- have a mandate to an approved electronic payment scheme accepted by The Darlington Golf Club (Members) Ltd.

#### Conditions

- Membership represent a contract. This contract is made between The Darlington Golf Club (Members) Ltd and the Member.
- The Darlington Golf Club (Members) Ltd can accept no responsibility for the approval of such a mandate by a bank nor can it accept any responsibility for any action taken or not taken by such a financial institution or agent acting on behalf of the financial institution.
- Membership will be suspended following any missed payment until EITHER
  - payment of the entire balance outstanding for 2010 is received; OR
  - payment of arrears is received and a new payment schedule for the remainder of 2010 is agreed; OR
  - a new payment schedule for 2010 is agreed that incorporates the arrears.

Members who are suspended will not be allowed to play on the course, enter competitions or frequent the clubhouse.

- At the discretion of the Darlington Golf Club (Members) Ltd the facility to pay membership subscriptions by monthly instalment will be withdrawn if the Darlington Golf Club (Members) Ltd experiences frequent or persistent failures to collect payments.
- The Darlington Golf Club (Members) Ltd reserves the right to refuse to accept monthly instalment payments made other than by an acceptable scheme and to refuse to renew membership against such payments, e.g. the receipt of multiple cheques.
